1. The Director, Biju Patnaik Tribal Agro-biodiversity Centre, M. S. Swaminathan Research Foundation, Phulbad, Umuri Post, Jeypore-764002 invites **Item Rate Bid** for the following work detailed in the table below from the contractor as mentioned in column No.4 registered with the Government of Odisha for execution of Civil Works and similar type of works on production of definite proof from the appropriate authority. Bidders registered under other State Government / M.E.S. / Railways / CPWD in equivalent rank may participate in the tender works but the successful bidder has to register under the State (Odisha) P.W.D. before signing of the Agreement.

2. The bidder should have adequate experience of execution of similar type of work costing not less than Rs.6.61 (Six Lakh Sixty One Thousand) in last three financial years.

Bid documents consisting of plan, specification, the schedule of quantities and the set of terms and condition of the contract and the other documents can be seen in the above offices issuing the documents and the office of the undersigned during office hours every day except Sunday, 1st, 3rd and 5th Saturday and public holiday till last date of sale and receipt of tender paper. Interested bidders may obtain further information from the same address.
4. Bids must be accompanied by security of the amount specified for the above work in the column-4 of the table against Sl. No.1 drawn in favour of **MSSRF - SITE OFFICE JEYPORE** payable at Jeypore. Bid security will have to be in any one of the forms as specified in the bidding document. Bidders desirous to have machineries from outside the State are required to furnish 2% of the amount put to tender as bid security.
5. The sale and receipt of the Bid document shall **start from. 01.06.2021 at 9.00 hours and close on 15.06.2021 at 13.00 hours.** Bids must be delivered in the office having identification no. **DIRECTOR, MSSRF, Jeypore,** / 2021-22.

Bid documents can be purchased from the office mentioned in the office of the undersigned against non refundable fee towards cost of documents as indicated in the form of demand draft issued from any scheduled bank payable at Jeypore in favour of **MSSRF - SITE OFFICE JEYPORE**. In addition bid documents will be made available by mail / registered / speed post / on payment of an extra amount of Rs.500/- over the cost of bid document, if requested. The authority will not be held responsible for the postal delay if any in the delivery of the document or non receipt of the same.

Submitted tender should contain the self attested copies of the contractors valid license, valid Goods and services Tax Registration Certificate, PAN card and the prescribed security otherwise the bid will be declared as non responsive and thus liable for rejection. The original certificate of the first and second lowest bidder will be verified at the time of opening of the bids.
8. The bids will be opened on. **16.06.2021 at 11.00** Hours in the office of the undersigned in the presence of the bidder who wish to attend. If the office happens to be closed on the date of receipt/opening of the bid as specified, the bids will be received and opened on the next working day at the same time and venue.
9. For a particular work a bidder can submit only one tender paper. Submission of more than one tender paper by a bidder for a particular work will be liable for rejection for all such tender papers.
10. The contractor has to furnish an affidavit declaring the authenticity of the documents submitted by him for the work.
11. Contractor is required to abide by the fair wages clauses as introduced by Govt. of Odisha and will not pay less than the Fair wages fixed by Govt. to the laborers engaged by him for the work.
12. The authority reserves right to cancel any or all bids without assigning any reason thereof.
